Aim of the course and learning outcomes:

The course aims to gain knowledge in the field of agricultural economics and politics. Get an overview of the fundamental economic characteristics of agriculture as a sector in general, its role in the development of regions, the forms of agricultural markets, and their functioning in agribusiness's basic models and structure. Learn about the decisive factors shaping economic policy in agriculture and the agricultural sector and their concrete applications within the EU CAP. Acquire the ability to apply knowledge of the agricultural economy and policy in the context and dynamics of agricultural markets and systemically link regional development issues and agricultural policy. During the preparation and presentation of commodity studies, students will be guided to using relevant data and other information sources and applying adequate methods and techniques for processing analyses and their presentation.

Africa is a region with diverse development challenges. Right after independence many African countries, in their quest to catch up with the rest of the world embarked on industrialization without paying attention to one of the basic fundamentals that underpins development in the early stages of transformation -- development of the agricultural sector. Thus, import substitution and 'Statist' approaches to development that were implemented had less developmental impacts up to the early part of the 1980s. This led to the implementation of Structure Adjustment Programmes supported by the IMF and the World Bank. These programmes to some extent reversed the economic decline but with much economic, social and environmental challenges. Today, many African countries are faced with serious developmental challenges that threaten economic and social growth. The objective of this course is to provide students with fundamental knowledge of some of the key development challenges facing Africa today as well as efforts being made by the World and Africans themselves to overcome these challenges.

Aim of the course and learning outcomes:

How can one understand and navigate diplomatic relations as well as act naturally amid sundry social occasions? The purport of this course is to acquaint the students with the origins and the current position of diplomacy in the world politics. The course shall also stress the foundations of diplomatic law. Overall, the course shall offer an essential set of information which may be applied within an extensive common practice in the diplomatic service and other relevant institutions, such as the European Union (EU), United Nations (UN). Furthermore, the most crucial aspects of diplomatic protocol and etiquette shall be introduced and practised thoroughly. Afterwards, students may utilise their skills and knowledge of history and diplomatic protocol not only in diplomacy but event management, too.

This course has been set up for students to help them achieve the following: * Acquire a working knowledge of diplomacy and its origins and procedures; * Ability to discuss and analyse the contemporary affairs in English; * Improve communication and writing skills. Due to the structure of this course, however, it is imperative that one is in possession of at least the B2 level of English (CEFR) in order to understand and communicate in class. No certificates proving the level of English are required, though. Please note that this course is strictly for graduate (ie, MA) students only.

The course highly encourages the students to become familiar with and capable of engaging with manifold cruces in politics. And since this is a sphere of swift changes, so it is indispensable to keep abreast of current affairs. Hence, all the students are advised to follow and read, for instance, The Economist and The Financial Times on a regular basis, whilst other press may remain upon one's preference and liking.

Aim of the course and learning outcomes:

Growing environmental problems creates challenges for improving the management of natural resources and environmental protection in both developed and developing countries and for the development of global sustainable economy at international level.

The relationship between environmental protection and the economy has been an issue of public discussion for last decades. Does environmental protection tend to harm the economy or to facilitate economic growth? What are environmental limits of economic growth and how we can we deal with them? How it is possible to assess sustainability and can the positive and negative environmental affects be quantified and estimated at a meaningful level of detail? How can be individual behavior effectively influenced to harmonize it with collective interest of environmental protection and sustainable economic growth?

Economics, as the social science studying the allocation of scarce resources within society, can help meet these challenges effectively by providing explanations of the causes of environmental problems and potential solutions. Economic analysis can also help determine whether prospective policies succeed in aligning the private incentives of individuals, households, and firms with the public interest in improved resource management and higher environmental quality.

It is designed to provide a basic knowledge of theoretical and methodological framework of an economic analysis of the policy issues associated with applying the concept of sustainable development and environmental protection, and will be taught in an interdisciplinary fashion addressing the institutional, economic, and legal issues related to natural resource allocation. Particular topics that will be covered are: (1) the macroeconomic analysis of the relationships between the economic development and the environment at the different levels of the economic development; (2) environmental limits and economic; (3) the microeconomic analysis of environmental regulation; (4) the problem of economic assessment and social cost, (5) estimating cost and benefits of environmental policy impacts; (6) the use of economic information for the policy instrument choice.
